2. (U) LETTERS.

A. (U) PAGE 48. THE FIRST LETTER IS FROM ((AL-BATTAR)) ABD AL-MAILIK AL-RAHBI TO SHEIK ((ABU ABDALLAH)) (FIELD COMMENT-- SHEIK ABU ABDALLAH IS AN ALIAS USED BY OSAMA BIN LADEN.) THIS LETTER ASKS FOR PERMISSION TO FIGHT ON THE KASHMIR FRONT AND ASKS FORGIVENESS IF AL-BATTAR HAS NOT LIVED UP TO EXPECTATIONS. THE WRITER ALSO SENT HIS GREETING TO SHEIK ((ABU HAFS)). HE SIGNED THE LETTER AS - YOUR SON AND STUDENT. THE LETTER IS DATED 30 AUGUST 2000, KASHMIR. PAGE 49 CONTAINS ENVELOPE INFORMATION. IT SAID -- PERSONAL, PLEASE, IT SHOULD ONLY BE READ BY AL-SHEIKH.

B. (U) PAGES 51-53. THE SECOND LETTER IS ALSO FROM AL-BATTAR AND IS UNDATED. THE LETTER IS ADDRESSED TO ((ABUL KHULOUD)) AKA ABU HASHIM. THE TEXT EXPRESSES THE WRITER'S REGRET FOR NOT INFORMING ABUL KHULOUD ABOUT HIS TRAVEL PLANS. AL-BATTAR REQUESTS ABUL KHULOUD TO MOVE HIS FAMILY TO MUS'AB AL HASHIDY'S HOME OR BE ALLOWED TO WAIT FOR THE RETURN OF HIS WIFE'S BROTHER ((FAROUK)) AND BE TAKEN TO KABUL, AFGHANISTAN.

C. (C) PAGES 56-58. THE NEXT LETTER IS UNDATED, UNSIGNED AND UN-ADDRESSED. THIS LETTER ENCOURAGES THE READER TO EMBRACE JIHAD AGAINST UNBELIEVERS, JEWS AND TO SUPPORT OSAMA BIN LADEN.

D. (C) PAGE 60. THIS LETTER IS FROM JALLAD TO SAQR ((AL-JIDDAWI)) ASKING FOR 20-25 GENUINE RUSSIAN MADE PIKA BELTS AND THREE MILITARY COMPASSES FROM KABUL.

3. (C) PERSONAL WILLS --

A. (C) PAGE 55. THE FIRST WILL IS FROM AL-BATTAR TO HIS BROTHER ABU HASHIM. HE ALSO ADDRESSED IT TO HIS FATHER, MOTHER, BROTHERS, SISTERS, AND WIFE. THIS WILL WAS WRITTEN QUICKLY IN KASHMIR, KRIL, ON 30 AUGUST 2000.

B. (C) PAGE 63. THE SECOND WILL IS FROM ((ABU HAJAR)) AKA ABD AL-AZIZ BIN ISA AL-MUQRIN. THE WILL DISCUSSES THE DISPOSITION OF ABU HAJAR'S PERSONAL GOODS AND ENCOURAGES THE READER TO SUPPORT OSAMA BIN LADEN. AT THE BOTTOM OF HIS WILL, ABU HAJAR WROTE A MEMO TO HIS FRIEND ABD AL-MAJID ((AL-TABOUKI)) TO READ HIS WILL AND ADVISE HIS FAMILY OF HIS DEATH VIA THESE NUMBERS -- HIS BROTHER -
