

## STATEMENT OF WORK FOR IRAQ MEMORY FOUNDATION (IMF)

#### 1.0 B ACKGROUND

At the end of 35 years of Ba'athist rule and the fall of Saddam Hussein's regime, an Iraqi Oral History on Film can now be produced without putting documentary subjects at risk of certain retaliation. It is critical to future generations in Iraq that an archive of first-hand accounts by the survivors of Ba'athist atrocities be established.

2.0 APPLICABLE DOCUMENTS (Video Projects on DVD)

Saddam's Killing Fields documentary.

- 3.0 OBJECTIVE. The objective of this order is to establish a record of witnesses' testimony to atrocities committed upon the Iraqi people (and others) during the Ba'athist rule. A series of short documentaries would be created from this multi-media record and broadcast to the people of Iraq. The U.S. Government would also assist the contractor in distributing the documentaries to other global audiences to counter pro-Sadaam, pro-Ba'thist propaganda. The operational intent is to be apolitical; recording accounts of witnesses, collecting documents and relics.
- 3.1 Record 30–50 victim/witness testimonies of varying lengths, to be used in edited form for long-format documentaries for archival purposes and short-format interview segments for broadcast use. Produce at least one 15

minute documentary from each of these victim/witness testimonials. These personal testimonies will powerfully impart the brutalities of the former regime to the public and scholars.

- 3.2 Establish an Iraqi Audio-Visual archive, via producing and collecting visual material such as the regime's own footage of its own criminal behavior. The contractor will at all times have ownership rights and rights of usage of all footage in both raw and edited forms. USG recognizes the right of the contractor to copyright and retain control of all products based upon the raw footage that have been edited for its own use and distribution. The contractor may set and retain any financial considerations that result from sales, rentals, or any other licensing of its copyrighted products. USG retains the right to broadcast the 15-minute edited segments worldwide as well as in Iraq. (The U.S. Government shall have the license to show the edited segments, and license them for showing for one year from the date of the U.S. Government's receipt of the films. The U.S. Government shall require of the media entities with whom it contracts that they observe the contractor's copyright of the films, and that the films be shown only during the allotted one year period, by the media entities with whom the U.S. government contracts.)
  - 3.3 Build and train local Iraqi staff that will continue to maintain the goals of this project.
- 4.0 SCOPE. The government requires the contractor to collect documentary evidence of atrocities and crimes committed by the former Ba'athist regime of Iraq. The requires research involving first-hand testimonials, creation of video archives, editing of video footage for documentaries and collecting other documentary evidence of atrocities and crimes against humanity perpetrated by the former Ba'athist regime in Iraq against the people of Iraq.

## 5.0 SPECIFIC REQUIREMENTS AND SUBTASKS

- 5.1 Develop Work Plan. The contractor shall provide a written Work Plan to accomplish the subtasks within fifteen days of the delivery order's awarding. The Contracting Officer's Point of Contact (POC) shall provide the mutually agreed upon Work Plan.
- 5.2 International and Local Personnel. The contractor will hire teams of personnel for three locations, Baghdad, London, and Washington D.C., each with technical expertise and language skills commensurate with that location's needs.
- 5.2.1 Contract Manager. The contractor will provide a technical representative to oversee all aspects of the program from its outset to completion. Responsible for tracking expenses, reviewing expenditures versus milestone objectives, evaluating quality of products, and scrutinizing monthly progress reports. Requires travel for a minimum of three one-week visits during the period of performance. Must have in-depth knowledge of the latest upgrades in technical equipment and software for video, graphic design, and editing. Will provide periodic evaluations on equipment and software inventory.
- 5.2.2 Project Directors. Project Directors will will have progressive experience with project management, strategic planning, supervising staff and producing documentaries or other multi-media products.
- 5.2.3 Office Managers. They will assist the Project Directors in conducting research and supervising operations and staff, and will be involved in projects and initiatives at the direction of the Project Directors. Office Managers will operate under the established work plan.
- 5.2.4 Senior Researcher. Senior Researcher must have over ten years research experience preferably in Modern Arabian studies/Iraqi studies. Ability to supervise researchers in remote locations.
- 5.2.5 Researchers. Researchers must have previous experience working with archives, database management. History backgrounds with Arabic focus preferred. Experience conducting interviews and working with video crews preferred.
- 5.2.6 Cameraman/Director. The ideal candidate will be an expert in their field, with at least ten years experience creating documentaries and conducting interviews. Cameraman/Director will be responsible for training staff.
- 5.2.7 Senior Online Digital Video Editors. The ideal candidate will have at least five years experience editing video for documentaries, working with video crews and graphic designers and have current working knowledge of industry-standard hardware and software.

- 5.2.8 Assistant Editors. The ideal candidate will have at least two years experience editing video for documentaries, working with senior editors and graphic designers and have current working knowledge of industry-standard hardware and software.
- 5.2.9 Graphic Designers. The ideal candidate should have at least five years experience designing for video, working with video crews and video editors and have current working knowledge of industry-standard hardware and software.
- 5.2.10 Gaffers. The ideal candidate will have at least three years experience engineering lighting for video documentaries, assisting video crews, and expertise in electrical systems.
- 5.2.11 Grips. The ideal candidate will have at least three years experience working with lighting for video documentaries, assisting gaffers and video crews, and expertise in electrical systems.
- 5.2.12 Sound Engineers. The ideal candidate will have at least three years experience working with audio equipment for video, interfacing with video crews and specialists. Requires a strong understanding of music and speech mixing and integration. Must have current working knowledge of industry-standard hardware and software.
- 5.2.13 Production Assistants. The ideal candidate must have at least three years video production experience. Must have current working knowledge of industry-standard hardware and software.
- 5.2.14 Administrative Assistants. At least one of these personnel will have at least five years experience with managing finances, accounting, and personnel affairs in a production or agency environment.
- 5.2.15 Security Staff. Must maintain a secure environment, be aware of liabilities for the specific region, and have the ability to take appropriate actions.
- 5.2.16 Linguistic Services. Translation services as required for working with technical staff that may not have needed language skills.
- 6.0 The contractor will assume sole legal and contractual responsibility for acquisition of "other documentary evidence of atrocities and crimes against humanity perpetrated by the former Ba'athist regime in Iraq against the people of Iraq" as part of the contract, with the stipulation that it will only be required to purchase documentary evidence from legitimate copyright holders."
- 7.0 DELIVERABLES. The contractor team will provide strategic plans, progress reports, burn charts, and accountings. The contractor will produce interviews and documentaries for Iraqi Audio-Visual archive.
- 7.1 Release Forms. All subjects of interviewed testimonials or subjects who give any statement at all to be recorded on video must be required to sign a usage release form before any recordings are made. If no release is obtained, the subject footage will be deemed unusable.
- 7.2 The Deliverables as identified in Section 7.0, "Deliverables" will be considered accepted upon delivery.
- 8.0 GOVERNMENT FURNISHED PROPERTY/INFORMATION. The government will provide access to all applicable unclassified documents, photos, video footage, and information required to complete the task in paragraph 5 above. The government may broadcast the documentaries on government owned, operated or supported media facilities (e.g. Al-Hurra, Al-Iraqiya, et cetera) or similar media of coalition allies. The government will not own the copyright or distribution rights of the documentaries.
- 8.1 Risk of loss or damage during contract performance shall be borne by the U.S. Government. The property will be charged directly to the contract. However, at the expiration of the contract the property shall be dispositioned to The Iraqi Memory Foundation and contractor will have no further obligations with respect to said property from that point in time, and no adjustment shall be made to the amount charged for said property.
